The two candidates receiving the 3rd and 4th highest votes will serve two-year terms expiring at the adjournment of the annual meeting in 2025. The two candidates receiving the 5th and 6th highest votes will serve one-year terms expiring at the adjournment of the annual meeting in 2024.
